

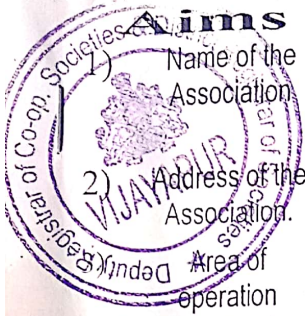

3. To conduct training programs & camps on various aspect such as health education and social aspects.
4. To enlist and accord registration on experience basis to deserving qualified person; medical students and those possessing adequate experiences in the (alternative medicines) alterative Medicines Courses of Studies.
5. To prepare Students in prescribed courses in the ELECTRO-HOMOEOPATHY/Alternative Medicine Science.
6. To provide latest modern and advance knowledge, technologies to paramedical students.
7. To open dispensaries , Hospitals , Medical Pathologies , Labs, Diagnostic Centre on Charitable basis in rural & urban areas of India & abroad.
8. To Promote. Propagate and advance the science of alternative systems of medicines such as ELECTRO-HOMOEOPATHY, Bach Flower Remedies, Psychological Counseling. Naturopathy, Hydrotherapy, Chromotherapy, Teletherapy, Gem Therapy, Radinics, Bioenegetics, Homoeopuncture, Reikhi, Magneto Therapy, Aromatherapy etc & to raise the status of alternative systems of medicines.
9. To advance the scientific study and professional practices of alternative medicines by encouraging its development by promoting research and setting high standards of professional ethics, competence, conduct, education, qualification and achievement amongst practitioners promoting the dissemination of knowledge and thought about alternative medicines through training, educational courses refresher courses, dataset, exhibitions, camps, publications professional contacts etc. With wide interest and inquiry into ELECTRO-HOMOEOPATHY/Alternative Medicines and all related areas of knoweldge and pratice
10. To maintain the honour and dignity and to uphold and safeguard to interests of ELECTRO-HOMOEOPATHY/Alternative Medicines alternative systems of medicine and other allied subjects.
11. To certify, permit, supervise and maintain a register of practitioners possessing degrees, diplomas or certificates etc. of the KEMA (council) or from any colleges or institute of alternative medicines either affiliated to the KEMA, or any authentic institute, and practitioners who have experience in any branch of ELECTRO-HOMOEOPATHY/Alternative Medicines of medicine by award of a registration certificate to them. Such a practitioner shall be known as a Registered Medical Practitioner (R.M.P)
12. To give the rights of practicing (Membership and Fellowship) to Registered Medical Practitioners enrolled by the KEMA (council) as qualified physicians, without any restriction, and entitling them to issue medical certificates such as sickness, fitness etc of any other certificate required by any law. To establish the faculty to control the examinations of teaching and educational institutions or colleges etc; and to award degrees (including PhD. M.D Master, Bachelor etc.) diplomas. Certificates etc., thereof.
13. To determine a uniform code of conduct for practitioners registered by KEMA (council).
14. To improve public health in accordance with the principles of Alternative systems of medicine.
15. To undertake publications relating to alternative medicines.
16. To establish. dispensaries, hospitals, research institutes etc. ELECTRO-HOMOEOPATHY/Alternative Medicines of alternative system of medicine.
17. To engage, assist or undertake various social activities as sanitation, public health, establishment of libraries, social welfare, pestilence and other calamities caused by nature and man.
18. To help the nation to arrive at the goal that by the 21st Century health will be for all.

19. The aim of the council is to overcome the gaps by providing qualities modern and affordable –education.
20. The organization KEMA (council) was formed to impart education research and development in Para Medical Science and Alternative Medicines.

NO HARASSMENT TO ALTERNATIVE MEDICAL PRACTITIONERS, HON'BLE SUPREME COURT OF INDIA

*Latest; Contents of judgment of Hon'ble supreme court of India .Dated:24.11.2000 (In the judgment and order Date 18.11.1998 in F.A.O. NO.205/92) For want of certain clarification etc. Delhi govt. & union of India (ministry of Health & family Welfare) has filled an appeal (SLP) in the Hon'ble supreme court of india challenging the order of Hon'ble Delhi high court DT.18.11.1998 upon hearing on 12.11.2000.the Division bench of Hon'ble justice R.C.Lahoti & Hon'ble justice Shivraj V.Patil has rejected the plea of Delhi Govt.& union of india and finally on 24.11.2000 the bench of the Hon'ble court comprising justice Rajendra Babu and B.N.Agarwal has directed to entertain the matter and SLP filled by petitioner (Delhi Govt.&union of india) has been dismissed.the Hon'ble supreme court of india also maintained that status quo of Hon'ble Delhi high court (FAO 205/92) DT.18.11.1998 by which it has been ordered that any legally constituted institution imparting Education facilities in the field of Alternative medicines may issue Diploma/certificate and holder of such diploma/certificate are entitled to practice the particular faculty/faculties covered by the said diploma/certificate.
